Proposal from Compass Point was reviewed in further detail. Compass Point was identified as a valuable resource that could greatly assist the Zoning Commission as current signage regulations are reviewed and potential modifications made. Using a professional firm should help move the process along more quickly while recognizing the importance of “having it right” in addition to mitigating any possible future law suits.
