2023-254. Mr. Richter moved to open the public hearing on the proposed 2024 Chester Township budget at 5:30 PM. Mr. Mazzurco seconded. Vote unanimous.; motion passed.

2023-255. Mr. Richter moved to waive the reading of the legal notice. Mr. Mazzurco seconded. Vote unanimous.; motion passed.

It was noted there was no public presence for questions except employees Mr. Neary, Mr. Osborne and Mr. Onyshko who are residents of Chester Township were in attendance.

General discussion concerning the 2024 Budget took place commenting on all Departments. A brief discussion on the opioid settlement came about. Inside millage was discussed and explained. Dialogue continued with special assessments and capital projects.

2023-256. Mr. Richter moved to approve the allocation of 1.5 of the inside millage from the road and bridge fund to the general fund effective for the 2024 calendar year showing that the 3.0 inside millage was allocated to the general fund. Mr. Mazzurco seconded.
