## **Board of Trustees response to Supplementary Conditions on variances**

The Board of Trustees agreed with the Geauga County Planning Commission's proposed change to the Geauga County Model Zoning regarding Board of Zoning Appeals ability to place supplementary conditions on submitted variances. This proposed Zoning Resolution change will be discussed and finalized at the next ZC meeting and moved forward.

## **Discussion on Signage**

Discussion of needs of Chester residents and businesses for signage. Brainstorming ways to solicit information from all Chester residents on appearance of signs. Thoughts included open forums to vocalize their needs and/or concerns.

Four kinds of signs identified for examination: Digital, wayfinding, mobile (ie-on vehicles) and billboards. (Concern about allowing digital signs may affect the billboard.) Trying to determine if any of these types of signs need to be adjusted in the Zoning Resolution. Will reach out to Zoning Inspector for help identifying most prominent requests for signs and any issues being faced by the Zoning Inspector.

## **Swimming Pool Covers**

Swimming pool covers and the safety of all Chester residents continues to be a concern for ZC members. Several board members had asked about viability of pool covers and protecting the safety of a residential swimming pool. Mr. Kats showed a video of himself walking on an automated pool cover. Open discussion of strengths and weaknesses of securing a pool in this manner continued.
